- 4) Where the Continuing Airworthiness Management Organisation contracts under its Quality System the service of an/several organisation(s), this approval remains valid subject to such organisation(s) fulfilling applicable contractual obligations.

Note: If this form is also used for AOC holders, the AOC number shall be added to the reference in addition to the approval number and these two following extra conditions should be applied:

- A) This approval does not constitute an authorization to operate the types of aircraft referred in scope of approval. The authorization to operate the aircraft is the Air Operator Certificate (AOC).
- B) Termination, suspension, revocation of the AOC automatically invalidates the present approval in relation to the aircraft registration specified in the AOC, unless otherwise explicitly stated by the GCAA.
- 5) This approval is valid as long as the Trade License remains valid.
- 6) This approval is valid as long as the Security Clearance remains valid.
- 7) Subject to compliance with the foregoing conditions, this approval shall remain valid for an unlimited duration unless the approval has previously been surrendered, superseded, suspended or revoked.y the GCAA.
